

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING CHAPTER 12, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES, ENTITLED "NUISANCES", BY AMENDING ARTICLE III, ENTITLED "MAINTENANCE OF SWALE AREAS", SPECIFICALLY AT SECTION 12-10, ENTITLED "STANDARD OF MAINTENANCE" TO PROHIBIT THE PLACEMENT OF SWINGS AND SIMILAR APPARATUS ON TREES IN THE SWALE AREA; PROVIDING FOR REPEAL, CONFLICTS, SEVERABILITY, CODIFICATION AND AN EFFECTIVE DATE.**

**WHEREAS**, a recent inspection of the City revealed that swings and similar apparatus are being placed on trees located in the swale area; and

**WHEREAS**, this practice serves as an attractive nuisance because it poses an inherent risk to children and passersby who choose to operate said equipment and who may become injured on the public rights of way; and

**WHEREAS**, the City of North Miami's current regulations address the standard of maintenance for swale areas, but do not include any prohibition on the placement of swings or similar apparatus in swale areas; and

**WHEREAS**, the Mayor and City Council desire to amend the Code of Ordinances to clearly establish regulations to prohibit the placement of swings or similar apparatus in the City's swale areas.

**NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, THAT:**

**Section 1. Amendments to Chapter 12 Code of Ordinances.** The Mayor and City Council of the City of North Miami, Florida, hereby amend Chapter 12, of the City of North Miami Code of Ordinances entitled "Nuisances", by amending Article 3, entitled "Maintenance of Swale Areas", specifically at Section 12-10, entitled "Standard of Maintenance" as follows:

**CHAPTER 12. NUISANCES**

**ARTICLE 3. MAINTENANCE OF SWALE AREAS**

**Sec. 12-10. Standard of maintenance.**

- (a) Swale areas will be considered maintained if all of the following requirements are met:
  - (1) Areas must be kept free from any accumulation of debris, litter, decayed vegetable matter, filth, rubbish, trash, discarded building materials, glass, or any other materials which are dangerous to the public health, safety and welfare;
  - (2) Areas must not be allowed to become overgrown with untended vegetation as defined in this chapter.
- (b) Sodding of the swale area shall be permitted. All such sodded areas shall be kept in good condition. The paving of any swale shall be prohibited.
- (c) The placement of swings or similar apparatus on trees located in the swale area shall be prohibited.
- (ed) Owner shall only permit parking of motor vehicles in swale area if it does not damage the sod or paved material on the swale.
- (de) No more than two (2) motor vehicles shall be allowed to park on the swale area at a time. Said parking shall be parallel to roadside and in the direction of the authorized traffic movement.

**Section 2. Repeal.** All ordinances or parts of ordinances in conflict herewith are repealed.

**Section 3. Conflicts.** In the event that the provisions of this Ordinance are in conflict with any other ordinance, rule or regulation, the provisions of this Ordinance shall prevail.

**Section 4. Severability.** The provisions of this Ordinance are declared to be severable, and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance, but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.


**Section 5. Codification.** It is the intention of the City Council of the City of North Miami and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of North Miami, Florida. The sections of this

Ordinance may be renumbered or re-lettered to accomplish such intentions; and the word "ordinance" may be changed to "section," "article" or any other appropriate word.

**Section 6. Effective Date.** This Ordinance shall become effective immediately upon adoption on second reading.
