

RESOLUTION NO. R-2012-115

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING AN AMENDMENT TO FISCAL YEAR 2011-2012 ADOPTED, AMENDED REVENUE AND EXPENSE BUDGETS, TO INCLUDE THE RECEIPT AND APPROPRIATION OF UNANTICIPATED REVENUES IN THE AMOUNT OF FIFTY-ONE THOUSAND EIGHT HUNDRED SIXTY-NINE DOLLARS (\$51,869.00), RESULTING FROM DONATIONS RECEIVED FROM INDIVIDUALS AND THE BUSINESS COMMUNITY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council passed and adopted an annual budget in accordance with the Charter of the City of North Miami ("City") for the current Fiscal Year 2011-2012, commencing October 1, 2011; and

WHEREAS, the City has received unanticipated revenues in the amount of Fifty-One Thousand Eight Hundred Sixty-Nine Dollars (\$51,869.00) of donations from individuals and the business community for specific purposes, as follows:

Haitian Heritage Celebration:	\$11,250.00
Back to School Bash & Health Fair:	\$31,537.00
Hispanic Heritage Celebration:	\$2,500.00
Women's Club Donation for Library Books:	\$500.00
San Souci Demo Day:	\$2,672.00

WHEREAS, City administration respectfully requests the ratification of the amendment to Fiscal Year 2011-2012 adopted, amended revenue and expense budgets for the purchase of goods, supplies, refreshments, entertainment venues, library books, and improvements to the San Souci Tennis Facility.



Section 1. Amendment of Budget. The Mayor and City Council of the City of North Miami, Florida, hereby ratify an amendment to Fiscal Year 2011-2012 adopted, amended

revenue and expense budgets, to include the receipt and appropriation of unanticipated revenues in the amount of Fifty-One Thousand Eight Hundred Sixty-Nine Dollars (\$51,869.00), resulting from donations received from individuals and the business community.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.


