

RESOLUTION NO.     R-2012-127    

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DECLARING AS SURPLUS PROPERTY SIX (6) LODAL SIDE-LOADING GARBAGE PACKER VEHICLES, AND AUTHORIZING THE CITY MANAGER TO PLACE SUCH SURPLUS PROPERTY FOR AUCTION WITH LONESTAR AUCTIONEER, IN ACCORDANCE WITH SECTION 7-145 OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) owns six (6) Lodal Side-Loading Garbage Packer Vehicles formerly used for sanitation services throughout the City, with mileage ranging from Twenty-Eight Thousand (28,000) miles to Seventy-Three Thousand (73,000) miles (“Surplus Property”); and

**WHEREAS**, the Surplus Property, as particularly described in the attached “Exhibit A”, is estimated to have an aggregate value in the amount of One Hundred Seventy-Six Thousand Dollars (\$176,000.00); and

**WHEREAS**, the Surplus Property is no longer in use and is becoming increasingly obsolete, without the benefit of serving a public purpose; and


**WHEREAS**, the City administration respectfully requests that the Mayor and City Council declare the six (6) vehicles as Surplus Property and authorize the City Manager to place such Surplus Property for auction, in accordance with Section 7-145 of the City of North Miami Code of Ordinances.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Declaration of Surplus and Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby declare as surplus property six (6) Lodal Side-Loading Garbage Packer Vehicles (as particularly described in the attached “Exhibit A”), and authorize the City Manager to place such surplus property for auction with Lonestar Auctioneer, in accordance with Section 7-145 of the City of North Miami Code of Ordinances.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.



Vehicle #4013 is a 2004 Lodal Side Loading Garbage Packer. It has 72,970 miles and is in fair condition. Engine, 6 cylinder Cat C275 CID diesel is in fair running condition. It is equipped with A/C, (not working), duel steering, and a AM/FM radio. Interior dash and seats are in fair condition. Trash Body is in fair condition. Hydraulic valve leaks. **Resale value \$32,000**

Vehicle #4014 is a 2004 Lodal Side Loading Garbage Packer. It has 41,211 miles and is in fair condition. Engine, 6 cylinder Cat C275 CID diesel is in fair running condition. It is equipped with A/C, (not working), duel steering, and a AM/FM radio. Interior dash and seats are in fair condition. Trash Body is in poor condition. Hydraulic valve leaks. **Resale value \$28,000**

Vehicle #4015 is a 2004 Lodal Side Loading Garbage Packer. It has 66,541 miles and is in fair condition. Engine, 6 cylinder Cat C275 CID diesel is in fair running condition. It is equipped with A/C, (not working), duel steering, and a AM/FM radio. Interior dash in bad condition, seats are in fair condition. Trash Body is in poor condition. Hydraulic valve leaks. **Resale value \$28,000**

Vehicle #4016 is a 2004 Lodal Side Loading Garbage Packer. It has 51,314 miles and is in fair condition. Engine, 6 cylinder Cat C275 CID diesel is in fair running condition. It is equipped with A/C, (not working), duel steering, and a AM/FM radio. Interior dash and seats are in fair condition. Trash Body is in poor condition.
