

RESOLUTION NO. R-2012-59

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE AMENDMENT TO FISCAL YEAR 2011-2012 ADOPTED AMENDED REVENUE AND EXPENSE BUDGETS, TO INCLUDE THE RECEIPT AND APPROPRIATION OF FUNDS FROM THE COMMUNITY REDEVELOPMENT AGENCY (CRA) IN THE AMOUNT OF FOUR HUNDRED THOUSAND DOLLARS (\$400,000.00), FOR THE CONTINUATION OF THE CITY OF NORTH MIAMI'S NEIGHBORHOOD BEAUTIFICATION PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council passed and adopted an annual budget in accordance with the Charter of the City of North Miami ("City") for the current Fiscal Year 2011-2012, commencing October 1, 2011; and

WHEREAS, the Community Redevelopment Agency ("CRA") had a total budget allocation of One Million Five Hundred Thousand Dollars (\$1,500,000.00) for funding the City's Neighborhood Beautification and Improvement Program ("Beautification Program"); and

WHEREAS, a total of One Million One Hundred Thousand Dollars (\$1,100,000.00) was used to fund the Beautification Program throughout the City, including: the removal of the Australian Pine trees along NE 16th Avenue to 135th Street; the planting of Live Oak trees at various swale locations; the installation of sidewalks and the redesigning of the entry-way to NE 6th Avenue; swale improvements at Sunkist Grove; and replacing and installing driveway approaches and installing sod within the general area of NW 7th Avenue west to NW 17th Avenue, from NW 119th Street to NW 135th Street; and


WHEREAS, City administration respectfully requests the ratification of the amendment to Fiscal Year 2011-2012 Adopted Amended Revenue and Expense Budgets to expend the remaining balance of Four Hundred Thousand (\$400,000.00) Dollars for the Beautification Program.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Amendment of Budget. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the amendment to Fiscal Year 2011-2012 Adopted Amended Revenue and Expense Budgets, to include the receipt and appropriation of funds from the Community Redevelopment Agency (CRA) in the amount of Four Hundred Thousand Dollars (\$400,000.00), for the continuation of the City of North Miami's Neighborhood beautification program.


Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.

PASSED AND ADOPTED by a 5-0 vote of the Mayor and City Council of the City of North Miami, Florida, this 8 day of May, 2012.




