

**RESOLUTION NO. R-2013-104**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE PROPOSED SCHEDULE OF FEES, PURSUANT TO ARTICLE IV, CHAPTER 13 OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES, ENTITLED "DANGEROUS INTERSECTION SAFETY", ALSO KNOWN AS THE "RED LIGHT CAMERA ORDINANCE" AS AUTHORIZED BY SECTION 316.0083, FLORIDA STATUTES (2013); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, on June 25, 2013, the Mayor and City Council of the City of North Miami ("City") adopted Ordinance No. 1357, amending Article IV, Chapter 13 of the City of North Miami Code of Ordinances ("City Code"), entitled "Dangerous Intersection Safety", also known as the "Red Light Camera Ordinance" pursuant to Section 316.0083, Florida Statutes (2013); and

**WHEREAS**, the amended ordinance provided for a local code enforcement municipal hearing program ("Program") in the City of North Miami ("City") to enforce red light camera violations; and

**WHEREAS**, the Mayor and City Council also adopted Resolution 2013-75, which authorized the City Manager to utilize City's resources, staff, and contracted magistrates to implement the City's Program; and

**WHEREAS**, following an analysis of personnel and administrative costs including but not limited to processing, scheduling, reviewing, investigating, prosecuting and hearing red light camera violation cases before the local hearing officer, City administration is recommending approval of the following Fee Schedule, attached hereto as "Exhibit A," in accordance with Section 316.0083(5), Florida Statutes (2013); and

**WHEREAS**, the Mayor and City Council have determined that the Proposed Schedule of Fees is fair, reasonable and in the best interest of the residents and City of North Miami.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


