

RESOLUTION NO. R-2013-125

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND BUZZY KIDS, INC., TO FACILITATE A PARENT-LED EDUCATIONAL PROGRAM AT THE ENCHANTED FOREST COMMUNITY CENTER FOCUSING ON THE ARTS, COMMUNITY ORGANIZATION AND LEADERSHIP, FOR CHILDREN BETWEEN TWO (2) THROUGH SIX (6) YEARS OF AGE; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, Buzzy Kids, Inc. (“Buzzy Kids”), is a Florida not-for-profit community organization with the mission of involving children, parents, and the community with early childhood education, dedicated for children between the ages of two (2) through six (6) years; and

WHEREAS, Buzzy Kids desires to institute a program at the Enchanted Forest- Elaine Gordon Park Community Center, located at 1725 NE 135th Street, to provide an affordable, high quality parent-led curriculum focusing on the arts, community organization and leadership (“Program”); and

WHEREAS, participation in the Program is considered a vital component to the development of children, while offering immeasurable benefit to participating parents and the community at large; and

WHEREAS, City administration desires to support and facilitate Buzzy Kids’ commitment to improving the quality of life for the children in our community; and

WHEREAS, the Mayor and City Council find that entering into a Memorandum of Understanding, in substantially the attached form, to facilitate the provision of Program services is in the best interest of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to execute a Memorandum of

Understanding, in substantially the attached form, between the City of North Miami and Buzzy Kids, Inc., to facilitate a parent-led educational program at the Enchanted Forest Community Center focusing on the arts, community organization and leadership, for children between two (2) through six (6) years of age.


Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
