

RESOLUTION NO. R-2013-30

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO RENEW INVITATION FOR BID #15-09-10 PLUMBING EQUIPMENT AND SUPPLIES PREQUALIFICATION, TO PREQUALIFY VENDORS FOR FUTURE SPOT MARKET PURCHASES ON AN AS NEEDED, WHEN NEEDED BASIS, AT A COST NOT TO EXCEED THREE HUNDRED TWENTY THOUSAND DOLLARS (\$320,000.00), FOR THE TERM COMMENCING APRIL 13, 2013 THROUGH APRIL 12, 2014; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on February 3, 2010, the City of North Miami ("City") issued *Invitation for Bid #15-09-10 Plumbing Equipment and Supplies Pre-Qualification* ("IFB"), to prequalify vendors, licensed and authorized to sell various types of plumbing equipment and supplies on an as needed, when needed basis ("Supplies"); and

WHEREAS, on April 13, 2010, the Mayor and City Council approved the award and prequalification of a list of vendors to provide the City with Supplies, in accordance with the terms, conditions and specifications of the IFB; and

WHEREAS, the market prices for plumbing equipment and supplies have a tendency to fluctuate throughout the year, requiring the need to reevaluate the cost of Supplies and the list of approved vendors; and

WHEREAS, the IFB was developed to ensure that the City could obtain needed Supplies from authorized sellers of specified manufacturers offering the lowest fixed price from a reliable source, while meeting the precise specifications and requirements of the purchase order; and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to renew the IFB in order to continue the availability of Supplies at a competitive rate, at any time such purchase is necessary.



Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to renew Invitation for Bid #15-09-10


Plumbing Equipment and Supplies Prequalification, to prequalify vendors for future spot market purchases on an as needed, when needed basis, at a cost not to exceed Three Hundred Twenty Thousand Dollars (\$320,000.00), for the term commencing April 13, 2013 through April 12, 2014.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.


