

RESOLUTION NO. R-2013-41

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, PROCLAIMING MAY 2013 AS "MAKE YOUR CITY GREEN MONTH"; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami recognizes vehicle emissions as a major contributor to air pollution; and

WHEREAS, vehicle emissions can be greatly decreased by a reduction in peak hour and single occupancy trips; and

WHEREAS, the continued growth, safety and prosperity of our city and its residents requires positive action towards reducing air pollution; and

WHEREAS, South Florida Commuter Services, a program of the Florida Department of Transportation has established the "Make Your City Green Campaign" in the month of May to encourage commuters to leave their single-occupancy vehicles at home and use alternatives means of travel such as carpooling, biking, or walking; and

WHEREAS, The City of North Miami supports this call to action to participate in "Make Your City Green Campaign" for the month of May.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Proclamation of the City Council. The Mayor and City Council of the City of North Miami, Florida, hereby proclaim May 2013 as "**Make Your City Green Month**" in North Miami and urge all of our citizens and employees to participate in the Make Your City Green activities to improve our quality of life.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
