

RESOLUTION NO. R-2013-50

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF AN ELECTION FOR COUNCILPERSON FOR DISTRICT NO. 2 IN THE CITY OF NORTH MIAMI, HELD ON MAY 14, 2013; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council of the City of North Miami, pursuant to Resolution 2013-8, called for a regular election which was held on May 14, 2013, in accordance with the Charter of the City of North Miami; and

WHEREAS, pursuant to law, the results of that election are to be canvassed and certified by the City Council.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Canvassing Returns. That the Mayor and City Council of the City of North Miami, Florida, have publicly canvassed the returns of the election of May 14, 2013, and have found that 1,647 total ballots were cast at the election for Councilperson for District No. 2.

Section 2. Election Results. That the Mayor and City Council of the City of North Miami, Florida, have found that 1,647 valid votes were cast for the office of Councilperson for District No. 2, as follows:

254 votes for MICHAEL BLYNN

142 votes for JOSEPH HABER

435 votes for MARY C. IRVIN

816 votes for CAROL KEYS

Section 3. Canvassing Board Findings. That the Mayor and City Council of the City of North Miami, Florida, hereby acknowledge that the Miami-Dade County Canvassing Board has found that MARY C. IRVIN and CAROL KEYS have received the two (2) highest number of votes, and pursuant to the City Charter, a run-off election shall be held in the City on June 4, 2013, between these two (2) candidates for the office of Councilperson for District No. 2.


Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.

PASSED AND ADOPTED by a 3-0 vote of the Mayor and City Council of the City of North Miami, Florida, this 28 day of May, 2013.




