

RESOLUTION NO. R-2013-55

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, ADOPTING THE CITY OF NORTH MIAMI DOWNTOWN MASTER DEVELOPMENT AND MAJOR CORRIDOR PLAN TO SERVE AS A DESIGN GUIDE FOR FUTURE DEVELOPMENT AND REDEVELOPMENT; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, Policy 1.2.2 of the City of North Miami (“City”) Comprehensive Plan (“Comprehensive Plan”) requires the City to prepare plans for major corridors, including: Northeast 6th Avenue; Dixie Highway; Northeast 135th Street; Northeast 125th Street; Northwest 119th Street; and Biscayne Boulevard; and

WHEREAS, Policy 1.4.1 of the Comprehensive Plan, also requires that the City “adopt guidelines for unified urban design, architectural and landscape regulations for major corridors to further assist in creating a sense of place throughout the City”; and

WHEREAS, in order to implement the vision and Policies of the Comprehensive Plan, the City retained the firm of Keith & Schnars P.A., to develop architectural and urban design guidelines for the City’s downtown area and major corridors entitled, Downtown Master Development and Major Corridor Plan (“Master Plan”), attached hereto as “Exhibit A”; and

WHEREAS, the Master Plan has been developed to serve as a visual design guide for future development and redevelopment of the downtown core area and major corridors, to further advance the objectives of the Comprehensive Plan and Land Development Regulations; and

WHEREAS, City Administration believes the proposed Master Plan embodies the collective insight of various stakeholders, including elected and appointed officials, City staff, business owners and City residents; and thereby, respectfully recommends approval and adoption of the Master Plan; and


WHEREAS, the Mayor and City Council have reviewed the proposed Master Plan and find that it serves as an effective guiding document for future development, and further advances the vision of the Comprehensive Plan in the best interest of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of the Master Plan. The Mayor and City Council of the City of North Miami, Florida, hereby adopt the City of North Miami Downtown Master Development and Major Corridor Plan (attached hereto as "Exhibit A") to serve as a design guide for future development and redevelopment.


Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
