

RESOLUTION NO. R-2013-59

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF A RUNOFF ELECTION FOR COUNCILPERSON FOR DISTRICT NO. 2 IN THE CITY OF NORTH MIAMI, HELD ON JUNE 4, 2013; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council of the City of North Miami, pursuant to Resolution No. R-2013-8, called for a runoff election which was held on June 4, 2013, in accordance with the Charter of the City of North Miami; and

**WHEREAS**, pursuant to law, the results of that election are to be canvassed and certified by the City Council.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA THAT:**

**Section 1. Canvassing Returns.** The Mayor and City Council have publicly canvassed the returns of the election of June 4, 2013 and have found that 1,871 total ballots were cast at the election for Councilperson for District No. 2.


**Section 2. Election Results.** The Mayor and City Council have found that valid votes were cast for the office of Councilperson for District No. 2 as follows:


712 votes for MARY C. IRVIN


1,159 votes for CAROL KEYS

**Section 3. Canvassing Board Findings.** The Mayor and City Council sitting as the Canvassing Board have found that CAROL KEYS has received the highest number of votes for Councilperson for District No. 2, and that CAROL KEYS is declared elected and shall hold office as Councilperson for District No. 2 until the second Tuesday next following the general election in May 2017.
