

RESOLUTION NO. R-2013-69

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR A GRANT FROM THE OCCUPANT PROTECTION AND CHILD SAFETY PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of applying for and securing a grant from the Florida Department of Transportation's Occupant Protection and Child Safety Program; and

WHEREAS, the City of North Miami ("City") is requesting a grant for a project at a total cost of Fifty Thousand Dollars (\$50,000.00) in grant funds with no required match; and

WHEREAS, funds will be used by the North Miami Police Department in its efforts to increase seat belt use and child protection safety within the City by providing presentations focused on the importance of seat belt protection and distributing public information and educational materials through fairs, community events, and school functions; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the Florida Department of Transportation for the purpose of securing grant funds.



Section 1. Authorization to Submit Grant Application. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submittal of the City of North Miami's application for a grant from the Florida Department of Transportation's Occupant Protection and Child Safety Program.



Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.


