

RESOLUTION NO. R-2013-74

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF METRO EXPRESS, INC., AS THE TOP RANKED CONTRACTOR FOR THE PROVISION AND PLACEMENT OF HOT-MIXED ASPHALT AS APPROVED BY THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR RESURFACING STREETS, ALLEYWAYS AND OTHER PUBLIC RIGHTS-OF-WAY, IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN THE INVITATION FOR BID NO. 25-12-13 ASPHALT LAID IN PLACE, AT A COST NOT TO EXCEED THREE HUNDRED THOUSAND DOLLARS (\$300,000.00), AND FURTHER AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS FOR THE PROVISION OF THE STATED SERVICES ON AN AS NEEDED, WHEN NEEDED BASIS; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on April 9, 2013, the City of North Miami ("City") advertised *Invitation For Bid IFB No. 25-12-13 Asphalt Laid In Place* ("IFB") to establish a source of labor, supervision, materials, equipment, tools and services necessary for asphalt laid-in-place at various locations throughout the City on an as needed, when needed basis, in accordance with the terms, conditions, and specifications contained in the IFB ("Services"); and

WHEREAS, Metro Express, Inc. ("Contractor"), timely submitted its bid and was evaluated by City administration as the lowest responsive, responsible bidder whose bid, qualifications and references demonstrated to be the most advantageous to the City in the procurement of Services; and

WHEREAS, the Contractor has expressed its capability, expertise and willingness to perform the Services pursuant to IFB requirements, for a term of one (1) year with the option to renew by the City for an additional four (4) years, on a year-by-year basis; and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interests to approve the selection of Contractor and authorize the City Manager to issue purchase orders for the provision of Services on an as needed, when needed basis.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Selection and Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of Metro Express, Inc., as the top ranked contractor for the provision and placement of hot-mixed asphalt as approved by the Florida Department of Transportation for resurfacing streets, alleyways and other public rights-of-way, in accordance with the terms, conditions, and specifications contained in the *Invitation for Bid No. 25-12-13 Asphalt Laid in Place*, at a cost not to exceed Three Hundred Thousand Dollars (\$300,000.00), and further authorize the City Manager to issue purchase orders for the provision of the stated services on an as needed, when needed basis.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.

PASSED AND ADOPTED by a 5-0 vote of the Mayor and City Council of the City of North Miami, Florida, this 25 day of June, 2013.


