

**A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMISSION OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE NATIONAL RECREATION AND PARKS ASSOCIATION (NRPA) FOR A GRANT FROM GROW YOUR PARK PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, the Vice Mayor as Acting Mayor and City Council are desirous of applying for and securing a Grow Your Park Grant from the National Recreation and Parks Association (NRPA); and

**WHEREAS**, the City of North Miami ("City") is requesting a grant for a project at a total cost of Ten Thousand Dollars (\$10,000.00) in grant funds with no required match; and

**WHEREAS**, funds will be used for the construction, refurbishment or improvement of community gardens located in public parks and on public land; and

**WHEREAS**, the Vice Mayor as Acting Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the National Recreation and Parks Association (NRPA) for the purpose of securing grant funds.

**NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification of Submission of Grant Application.** The Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, hereby ratify the submission of the City of North Miami's application for a grant from the National Recreation and Parks Association's Grow Your Park grant program.


