

RESOLUTION NO. 2014-R-61

A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S RANKING AND SELECTION OF JONES BENITEZ CORPORATION, AS THE LOWEST RESPONSIVE-RESPONSIBLE CONTRACTOR TO FURNISH ALL LABOR, MATERIALS, EQUIPMENT, FACILITIES, TOOLS, SUPPLIES, MAINTENANCE OF TRAFFIC, ROOT PRUNING, SPRINKLER AND DRIVEWAY REPAIRS, RESTORATION OF ABUTTING AREAS, AND OTHER RELATED SERVICES REQUIRED FOR SIDEWALK REPLACEMENT AND INSTALLATION AT SPECIFIED LOCATIONS, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN THE INVITATION FOR BID NO. 43-13-14 SIDEWALK REPLACEMENT & NEW INSTALLATION PROJECT – DISTRICT 3; FROM THE FY 13/14 CAPITAL IMPROVEMENT PROJECT BUDGET ALLOCATION, AND FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT TO COMPLETE THE PROJECT, AT A COST NOT TO EXCEED ONE HUNDRED EIGHTY-ONE THOUSAND FIVE HUNDRED SEVEN DOLLARS (\$181,507.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on May 9, 2014, the City of North Miami (“City”) advertised *Invitation for Bid No. 43-13-14 Sidewalk Replacement & New Installation Project – District 3* (“IFB”), to provide the City with all the labor, materials, equipment, facilities, tools, supplies, maintenance of traffic, root pruning, sprinkler and driveway repairs, restoration of abutting areas and other related services required for sidewalk replacement and installation at precise locations, in accordance with the terms, conditions and specifications contained in the IFB (“Project”); and

WHEREAS, Jones Benitez Corporation (“Contractor”), timely submitted its bid and was evaluated by City administration as the lowest responsive-responsible bidder whose bid, qualifications and references demonstrated to be the most advantageous to the City in the procurement of the Project; and

WHEREAS, the Contractor has expressed its capability, expertise and willingness to perform the Project pursuant to IFB requirements, at a cost not to exceed One Hundred Eighty-One Thousand Five Hundred Seven Dollars (\$181,507.00), from the Fiscal Year 2013-2014 Capital Improvement Project Budget Allocation; and

WHEREAS, in accordance with the ranking of Contractor by City administration, the City Manager respectfully requests that the Vice Mayor acting as Mayor and City Council approve the selection of Jones Benitez Corporation, in order to accomplish the required Project; and

WHEREAS, the Vice Mayor as Acting Mayor and City Council, find the Project advantageous to the public health, safety and welfare, and thereby authorize the City Manager and City Attorney to negotiate and execute an agreement to carry out the Project.

NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Vice Mayor acting as Mayor and City Council of the City of North Miami, Florida, hereby approve the City administration's ranking and selection of Jones Benitez Corporation, as the lowest responsive-responsible contractor to furnish all labor, materials, equipment, facilities, tools, supplies, maintenance of traffic, root pruning, sprinkler and driveway repairs, restoration of abutting areas, and other related services required for sidewalk replacement and installation at specified locations, in accordance with the terms, conditions and specifications contained in the *Invitation for Bid No. 43-13-14 Sidewalk Replacement & New Installation Project – District 3*.

Section 2. **Authority of the City Manager and City Attorney.** The Vice Mayor acting as Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement to complete the Project, at a cost not to exceed One Hundred Eighty One Thousand Five Hundred Seven Dollars (\$181,507.00).

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.


