

RESOLUTION NO. 2014-R-68

A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMISSION OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE TARGET CORPORATION FOR A TARGET EARLY CHILDHOOD READING GRANT TO BE USED TOWARD THE NORTH MIAMI PUBLIC LIBRARY PRIME TIME FAMILY PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the Vice Mayor as Acting Mayor and City Council are desirous of securing a grant from the Target Corporation; and

WHEREAS, the City of North Miami is requesting a grant in the amount of Two Thousand Dollars (\$2,000.00) in grant funds with no required match for a total project cost of Two Thousand Dollars (\$2,000.00); and

WHEREAS, funds will be used toward the North Miami Public Library Prime Time Family Program which is a free three (3) to six (6) week reading and discussion program that targets underserved families; and

WHEREAS, the program is facilitated by trained discussion leaders and storytellers utilizing award winning children's books to relate literature to real life and personal experiences; and

WHEREAS, on July 8, 2014, the Vice Mayor as Acting Mayor and City Council adopted Resolution No. 2014-R-56, authorizing the City Manager, City Attorney and City Clerk to take all necessary action and to execute all documents affecting the health, safety and welfare of the City during the City Council's recess from July 9, 2014 through September 8, 2014, subject to ratification; and

WHEREAS, the City submitted a grant application for the purpose of securing grant funds from the Target Foundation; and

WHEREAS, the Vice Mayor as Acting Mayor and City Council wish to ratify the submittal of a grant application, as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City of North Miami and the Target Corporation.


NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Application. The Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, hereby ratify the submission of the City of North Miami's application for an early childhood reading grant from the Target Corporation.




