

**RESOLUTION NO. 2014-R-79**

**A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, ADOPTING A TENTATIVE MILLAGE RATE OF 7.9336 MILLS FOR FISCAL YEAR 2014-2015; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami, Florida (“City”), has considered an Operating Budget for Fiscal Year 2014-2015 in accordance with the provisions of Section 200.065, Florida Statutes (2014); and

**WHEREAS**, the millage rate necessary to fund the City’s Operating Budget for Fiscal Year 2014-2015 is 7.9336 mills, which is 9.49% more than the rolled-back rate of 7.1808 mills; and

**WHEREAS**, in accordance with Section 200.065(5), Florida Statutes (2014), as amended from time to time, a majority vote of the Vice Mayor as acting Mayor and City Council is required to adopt a rate of up 7.9336 mills; and

**WHEREAS**, the Vice Mayor as Acting Mayor and City Council find that the adoption of the proposed tentative millage rate for fiscal year 2014-2015 is in the best interest of the City.

**NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Adoption of Tentative Millage Rate.** The Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, hereby adopt 7.9336 mills as the tentative millage rate on assessed property value, necessary to fund the City’s Fiscal Year 2014-2015 Operating Budget.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.

**PASSED AND ADOPTED** by a 4-0 vote of the Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, this 10<sup>th</sup> day of September, 2014.


