

**RESOLUTION NO. 2014-R-86**

**A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF NORTH MIAMI AND APPRISS, INC., TO PROVIDE FOR THE NORTH MIAMI POLICE DEPARTMENT'S PARTICIPATION IN THE FLORIDA INTEGRATED REPORT EXCHANGE SYSTEM (FIRES); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami ("City") and Appriss, Inc. ("Appriss") are desirous of entering into a Memorandum of Understanding ("MOU") with each other to provide for the North Miami Police Department's participation in the Florida Integrated Report Exchange System ("FIRES"); and

**WHEREAS**, the Florida Department of Highway Safety and Motor Vehicles ("DHSMV") in partnership with Appriss has implemented FIRES to serve as Florida's central repository for traffic records information; and

**WHEREAS**, the MOU will provide for the North Miami Police Department's ("NMPD") access to FIRES, which consists of historical crash report images and information which is useful to law enforcement in investigating traffic accidents; and

**WHEREAS**, as part of the MOU, citizens will have the option to purchase copies of crash reports utilizing a secure website ([www.buycrash.com](http://www.buycrash.com)) in addition to the current option of obtaining crash reports in person at the NMPD; and

**WHEREAS**, the Vice Mayor as Acting Mayor and City Council believe that a Memorandum of Understanding for this purpose will benefit the residents of the City and should be entered into with Appriss.

**NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**




