

RESOLUTION NO. 2014-R-91

A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF LIMOUSINES OF SOUTH FLORIDA, INC., FOR THE OPERATION AND MAINTENANCE OF CITYWIDE PUBLIC TRANSPORTATION SERVICES, IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN THE REQUEST FOR PROPOSAL NO. 48-12-13 COMMUNITY TRANSPORTATION SERVICES, AT A COST NOT TO EXCEED SIX HUNDRED THOUSAND DOLLARS (\$600,000.00) PER YEAR; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE A NON-EXCLUSIVE AGREEMENT FOR THE PROVISION OF STATED SERVICES, FOR A TERM OF THREE (3) YEARS WITH TWO (2) OPTIONS TO RENEW THE AGREEMENT, FOR A ONE (1) YEAR PERIOD EACH; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on January 14, 2003, the Mayor and City Council of the City of North Miami ("City") passed Resolution Number 2003-1, adopting a Transit Circulator Plan for the benefit of commuting City residents; and

WHEREAS, on September 16, 2013, the City administration prepared and advertised *Request for Proposals No. 48-12-13 Community Transportation Services* ("RFP"), seeking qualified, insured and experienced transportation companies to operate and maintain a public transportation system throughout the City ("Services"), and thereby implementing and effectuating the adopted Transit Circulator Plan; and

WHEREAS, in response to the RFP, Limousines of South Florida, Inc. ("Contractor") timely submitted its proposal and was evaluated by City administration as a responsive, responsible Service provider whose proposal, qualifications and references demonstrated to be the most advantageous to the City; and

WHEREAS, City administration respectfully requests that the Vice Mayor as Acting Mayor and City Council approve the selection of Contractor, and authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services for the benefit of commuting members of the public; and

WHEREAS, the Vice Mayor as Acting Mayor and City Council, find that entering into an agreement with Contractor for the provision of Services, is advantageous to the public health, safety and welfare, and thereby, is in the best interest of the City.

NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Selection Approval. The Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of Limousines of South Florida, Inc., for the operation and maintenance of citywide public transportation services, in accordance with the terms, conditions, and specifications contained in the *Request for Proposal No. 48-12-13 Community Transportation Services*, at a cost not to exceed Six Hundred Thousand Dollars (\$600,000.00) per year.

Section 2. Authority of City Manager and City Attorney. The Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute a non-exclusive agreement for the provision of stated services, for a term of three (3) years with two (2) options to renew the agreement, for a one (1) year period each.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.


