

RESOLUTION NO. 2014-R-97

**A RESOLUTION OF THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF AN APPLICATION AND AUTHORIZING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE MIAMI-DADE METROPOLITAN PLANNING ORGANIZATION (MPO) FOR GRANT FUNDS FROM THE MPO MUNICIPAL GRANT PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Miami-Dade Metropolitan Planning Organization (“MPO”) municipal grant program is intended to fund small scale transportation planning studies proposed by municipal governments in Miami-Dade County; and

**WHEREAS**, the City of North Miami (“City”) applied and was awarded a grant from the MPO in the amount of One Hundred Thousand Dollars (\$100,000.00) with a required match in the amount of Twenty Thousand Dollars (\$20,000.00) to come from the Half-Cent Transportation Surtax Fund for a total project budget in the amount of One Hundred Twenty Thousand Dollars (\$120,000.00); and

**WHEREAS**, the grant funds will be used towards a study in support of the Downtown Multi-Modal Traffic circulation plan and to identify potential multi-modal mobility, access and safety improvements for the 125<sup>th</sup> street corridor; and

**WHEREAS**, the traffic circulation study will provide alternatives to the current traffic patterns in the greater downtown North Miami area, to promote multi-modal transportation choices in the downtown core and to take advantage of planned infrastructure improvements.

**NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification of Submittal.** The Vice Mayor as Acting Mayor and City Council of the City of North Miami, Florida, hereby ratify the submission of an application to the Miami-Dade Metropolitan Organization Grant Program.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the Miami-Dade Metropolitan Organization.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.


