

RESOLUTION NO. 2015-R-24

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF A VICTIMS OF CRIME ACT (VOCA) GRANT APPLICATION, AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE STATE OF FLORIDA'S OFFICE OF THE ATTORNEY GENERAL; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami funds the North Miami Police Department's Crisis Intervention Specialist position, as well as computer hardware ensuring the timely and efficient completion of all reporting and referrals; and

WHEREAS, the Crisis Intervention Specialist provides crisis intervention for victims of violent crime with concentration on domestic violence with funding from the State of Florida's Office of the Attorney General; and

WHEREAS, the City of North Miami is requesting a grant in the amount of Seventy-Three Thousand Eight Hundred Forty-Four Dollars (\$73,844.00) from the State of the Florida Office of the Attorney General – U.S Department of Justice for the Victims of Crime Act (VOCA), with a match in the amount of Nineteen Thousand Six Hundred Seventy Dollars (\$19,670.00) from the general fund and Eight Thousand Eight Hundred Forty Dollars (\$8,840.00) of in-kind for a total project budget of One Hundred Two Thousand Three Hundred Fifty-Four Dollars (\$102,354.00); and

WHEREAS, the Mayor and City Council is authorizing the City Manager and City Attorney to submit an application, negotiate and execute an agreement between the City and the State of the Florida Office of the Attorney General – U.S Department of Justice for the Victims of Crime Act.


NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Submittal of Application. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submittal of the City of North Miami's application for a Victims of Crime Act (VOCA) grant from the State of Florida's Office of the Attorney General.

Section 2. Authority to City Manager and City Attorney. If granted, the City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the State of Florida's Office of the Attorney General for a Victims of Crime Act grant.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.


