

**RESOLUTION NO. 2015-R-43**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES FOR A GRANT FROM THE NATIONAL URBAN AND COMMUNITY FORESTRY PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

WHEREAS, the City administration of the City North Miami ("City") is desirous of applying for and securing a National Urban and Community Forestry Program grant from the Florida Department of Agriculture and Consumer Services; and

WHEREAS, the City is requesting a grant in the amount of Twenty Thousand Dollars (\$20,000.00) in grant funds with a required Twenty Thousand Dollars (\$20,000.00) in-kind match from the City for a total project cost in the amount of Forty Thousand Dollars (\$40,000.00); and

WHEREAS, the funds will be used to implement the strategies identified in the adopted Downtown Action/Concept Plan by planting trees in the downtown North Miami area.


**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authorization of Application.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submission of the City of North Miami's application for a grant from the Florida Department of Agriculture and Consumer Services National Urban and Community Forestry Program.



**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.


