

RESOLUTION NO. 2015-R-49

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AFFIRMING THE REELECTION OF THE MAYOR, COUNCIL MEMBER FOR COUNCIL DISTRICT NO. 1, AND THE CITY CLERK; AND CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF AN ELECTION HELD ON MAY 12, 2015, FOR COUNCIL MEMBER FOR COUNCIL DISTRICT NO. 4; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on February 25, 2015, the Mayor and City Council of the City of North Miami, Florida ("City"), pursuant to Article III, Section 10, Article VII, Section 36, and Article VIII, Section 58 of the City of North Miami Charter ("City Charter"), passed and adopted Resolution No. 2015-R-23, calling for an election on May 12, 2015, for the Mayor, two (2) Council members, one (1) for Council District No. 1 and one (1) for Council District No. 4, and the City Clerk of the City of North Miami, in accordance with the City Charter; and

WHEREAS, pursuant to law, the results of that election are to be canvassed and certified by the Mayor and City Council.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Re-election of the Mayor.** That the Mayor, Dr. Smith Joseph, having met no opposition in the elections of May 12, 2015, is hereby deemed re-elected to the Office of Mayor for a term of two (2) years, pursuant to the City Charter.

Section 2. **Re-election of Council Member for Council District No. 1.** That Councilman Scott Galvin, having met no opposition in the elections of May 12, 2015, is hereby deemed re-elected as Councilman for City Council District No. 1 for a term of four (4) years, pursuant to the City Charter.

Section 3. **Re-election of City Clerk.** That the City Clerk, Michael A. Etienne, Esq., having met no opposition in the elections of May 12, 2015, is hereby deemed re-elected as City Clerk for a term of four (4) years, pursuant to the City Charter.

Section 4. **Canvassing Returns.** That the Mayor and City Council, have publicly canvassed the returns of the election of May 12, 2015, and have found that 1,591 total ballots were cast at the election for Council member for Council District No. 4.

Section 5. **Election Results.** That the Mayor and City Council, have found that 1,581 valid votes were cast for Council member for Council District No. 4, as follows:

- 573 votes for ALIX DESULME
- 488 votes for CARLINE PAUL
- 250 votes for ROSELINE J. PHILIPPE
- 229 votes for BEVERLY HILTON
- 41 votes for JESSICA ALSTON

Section 6. **Canvassing Board Findings.** That the Mayor and City Council, hereby acknowledge that the Miami-Dade County Canvassing Board has found that ALIX DESULME and CARLINE PAUL received the two (2) highest number of votes, and pursuant to the City Charter and Resolution No. 2015-R-23, a run-off election shall be held on June 2, 2015, between these two (2) candidates for Council member of Council District No. 4.

Section 7. **Effective Date.** This Resolution shall become effective immediately upon adoption.

PASSED AND ADOPTED by a 5 - 0 vote of the Mayor and City Council of the City of North Miami, Florida, this 26th day of May, 2015.




