

RESOLUTION NO. 2015-R-63

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UNITED STATES DEPARTMENT OF JUSTICE FOR A GRANT FROM THE BULLETPROOF VEST PARTNERSHIP PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the Bulletproof Vest Partnership Program was instituted by the United States Department of Justice to help protect the lives of law enforcement officers by assisting state and local governments to equip their law enforcement personnel with bulletproof vests; and

WHEREAS, the City of North Miami ("City") applied for a grant from the United States Department of Justice Bulletproof Vest Partnership Program; and

WHEREAS, the City requested a grant in the amount of Six Thousand Five Hundred Forty Dollars (\$6,540.00) with a required match in the amount of Six Thousand Five Hundred Forty Dollars (\$6,540.00) from the general fund for a total project budget in the amount of Thirteen Thousand Eighty Dollars (\$13,080.00); and

WHEREAS, funds will be used toward the purchase of required National Institute of Justice approved bulletproof vests for law enforcement officers; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of the grant application as well as to fully authorize the negotiation and execution of the agreement between the City and the United States Department of Justice for the purpose of securing grant funds.


NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Submittal of Grant Application. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submittal of the City of North Miami's application for a grant from the United States Department of Justice.

Section 2. Authority to City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the United States Department of Justice.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.

PASSED AND ADOPTED by a 5 - 0 vote of the Mayor and City Council of the City of North Miami, Florida, this 23rd day of June, 2015.




