

RESOLUTION NO. 2015-R-69

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SUBMISSION OF AN APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND GLOBAL GREEN USA TO SECURE A 2015 SUSTAINABLE NEIGHBORHOOD ASSESSMENTS GRANT; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council of the City of North Miami ("City") are desirous of applying for and securing a 2015 Sustainable Neighborhood Assessments Grant from Global Green, USA; and

**WHEREAS**, assistance is based on the LEED for Neighborhood Development standard, which provides a nationally recognized method for creating neighborhoods that are walkable, bikeable, resource-efficient and equitable; and

**WHEREAS**, the City is requesting grant funds in the amount of Twenty Thousand Dollars (\$20,000.00) with no required match for a total project cost in the amount of Twenty Thousand Dollars (\$20,000.00); and

**WHEREAS**, funds will be utilized toward technical assistance to assess the future impact of Tri-Rail Coastal Link Commuter Rail Train to the Oak Ridge Park subdivision; and

**WHEREAS**, the assessment will provide recommendations for physical and policy changes using LEED for Neighborhood Development Standards; and

**WHEREAS**, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and Global Green USA.



**Section 1. Approval of Submission of Grant Application.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the submission of the City's application for the Global Green USA 2015 Sustainable Neighborhood Assessments' Grant.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and Global Green USA to obtain grant funds.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.


