

RESOLUTION NO. 2015-R-95

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE NORTH MIAMI LIBRARY'S STRATEGIC MANAGEMENT PLAN AND THE ANNUAL PLAN OF SERVICE FOR FISCAL YEAR 2015-2016; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the State Aid to Library Grant Program is an important component of providing library services to the citizens of the City North Miami ("City"); and

WHEREAS, as part of its application to the State Aid to Library Grant Program, the City is required to submit a strategic management plan and an annual plan of service for the North Miami Library; and

WHEREAS, the City Manager has reviewed the North Miami Library's Strategic Management Plan and the Annual Plan of Service for Fiscal Year 2015-2016, attached as Exhibit "1" and Exhibit "2", and recommends its approval.


