

RESOLUTION NO. 2016-R-36

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF ZTI, LLC, AS THE LOWEST, RESPONSIVE BIDDER FOR THE PROVISION OF SWIMMING POOL RESURFACING SERVICES, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN THE THOMAS SASSO POOL DECK RESURFACING INVITATION TO BID NO. 16-15-16; FURTHER AUTHORIZING THE INTERIM CITY MANAGER AND INTERIM CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT FOR THE PROVISION OF STATED SERVICES WITH ZTI, LLC, AT A COST NOT TO EXCEED SEVENTY-SIX THOUSAND FIVE HUNDRED SIXTY-FIVE DOLLARS (\$76,565.00); AND IN THE EVENT NEGOTIATIONS FAIL, AUTHORIZING THE INTERIM CITY MANAGER AND INTERIM CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE NEXT LOWEST, RESPONSIVE FIRM UNTIL AN AGREEMENT IS EXECUTED; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

WHEREAS, on February 16, 2016, the City of North Miami ("City") advertised *Invitation for Bid Thomas Sasso Pool Deck Resurfacing IFB No. 16-15-16* ("IFB"), requesting sealed bids from licensed and insured contractors for the resurfacing of a pool deck area of approximately 12,500 square feet at the specified location, in accordance with the terms, conditions and specifications contained in the IFB ("Services"); and

WHEREAS, on March 3, 2016, City administration opened and reviewed timely-submitted sealed bids, ranking each response in the order of cost from the lowest to the highest, as follows: 1) ZTI, LLC, at \$76,565.00; 2) GC Works Inc., at \$77,840.00; and Advanced Surfaces, Inc., at \$120,600.00; and

WHEREAS, in accordance with City administration's ranking, the Interim City Manager respectfully requests that the Mayor and City Council approve the selection of ZTI, LLC, as the lowest bidder in the provision of Services ("Contractor"), and authorize the Interim City Manager and Interim City Attorney to negotiate and execute an agreement for Services at a cost not to exceed Seventy-Six Thousand Five Hundred Sixty-Five Dollars (\$76,565.00); and

**WHEREAS**, Services are expected to be completed within thirty (30) days from the City's issuance to Contractor of a Notice to Proceed; and

**WHEREAS**, in the event negotiations with Contractor fail, to then be authorized to negotiate and execute an agreement with GC Works Inc., as the second lowest bidder of Services at a cost not to exceed Seventy-Six Thousand Five Hundred Sixty-Five Dollars (\$77,840.00); and if deemed necessary, to proceed with Advanced Surfaces, Inc., at a cost not to exceed One Hundred Twenty Thousand Six Hundred Dollars (\$120,600.00), as the next lowest and final bidder of Services.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of ZTI, LLC, as the lowest, responsive bidder for the provision of swimming pool resurfacing services, in accordance with the terms, conditions and specifications contained in the *Thomas Sasso Pool Deck Resurfacing Invitation to Bid No. 16-15-16*.


**Section 2.**      **Authority of Interim City Manager and Interim City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and Interim City Attorney to negotiate and execute an agreement for the provision of stated services with ZTI, LLC, at a cost not to exceed Seventy-Six Thousand Five Hundred Sixty-Five Dollars (\$76,565.00); and in the event negotiations fail, authorizing the Interim City Manager and Interim City Attorney to negotiate and execute an agreement with the next lowest, responsive firm until an agreement is executed.

**Section 3.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
