

RESOLUTION NO. 2016-R-39

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF SOLUTIONS CAPITAL GROUP, INC., AS THE LOWEST, RESPONSIVE LOCAL BIDDER FOR THE CONSTRUCTION OF CONCRETE WALLS AT DESIGNATED LOCATIONS, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN THE INVITATION FOR BID CONCRETE WALL & TREX FENCE NO. 02-15-16, AS AMENDED; FURTHER AUTHORIZING THE INTERIM CITY MANAGER AND INTERIM CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT FOR THE PROVISION OF SUCH WALLS WITH SOLUTIONS CAPITAL GROUP, INC., AT A COST NOT TO EXCEED SIXTY-THREE THOUSAND NINE HUNDRED NINETY-FIVE DOLLARS (\$63,995.00); AND IN THE EVENT NEGOTIATIONS FAIL, AUTHORIZING THE INTERIM CITY MANAGER AND INTERIM CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE NEXT LOWEST, RESPONSIVE FIRM UNTIL AN AGREEMENT IS EXECUTED; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on January 14, 2016, the City of North Miami (“City”) advertised *Invitation for Bid Concrete Wall & Trex Fence No. 02-15-16*, as amended (“IFB”), requesting sealed bids from licensed and insured contractors to provide all the labor, materials, machinery, supplies, equipment and services necessary for the design and construction of concrete walls at designated locations, in accordance with the terms, conditions and specifications contained in the IFB (collectively referred to herein as “Services”); and

WHEREAS, on February 5, 2016, City administration opened and reviewed timely-submitted sealed bids, ranking each response in the order of cost from the lowest to the highest, as follows: 1) Solutions Capital Group, Inc.; 2) Hartzell Construction, Inc.; 3) CEEPCO Contracting, LLC; 4) Coramarca, Corp.; 5) GC Works, Inc.; 6) Caliste Construction, LLC; and 7) Paragon Construction, Inc.; and

WHEREAS, in accordance with City administration’s ranking, the Interim City Manager respectfully requests that the Mayor and City Council approve the selection of Solutions Capital Group, Inc., as the lowest, responsive-responsible local bidder in the provision of Services

("Contractor"), and authorize the Interim City Manager and Interim City Attorney to negotiate and execute an agreement at a cost not to exceed Sixty-Three Thousand Nine Hundred Ninety-Five Dollars (\$63,995.00), including a contingency amount of Five Thousand Dollars (\$5,000.00); and

WHEREAS, Services are expected to be completed within ninety (90) days from the City's issuance of a Notice to Proceed to Contractor; and

WHEREAS, in the event negotiations with Contractor fail, to then be authorized to negotiate and execute an agreement with Hartzell Construction, Inc., as the second lowest bidder of Services; and if deemed necessary, to proceed with CEEPCO Contracting, LLC, as the next lowest, responsive-responsible bidder of Services.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of Solutions Capital Group, Inc., as the lowest, responsive local bidder for the construction of concrete walls at designated locations, in accordance with the terms, conditions and specifications contained in the *Invitation for Bid Concrete Wall & Trex Fence No. 02-15-16*, as amended.


Section 2. **Authority of Interim City Manager and Interim City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and Interim City Attorney to negotiate and execute an agreement for the provision of such walls with Solutions Capital Group, Inc., at a cost not to exceed Sixty-Three Thousand Nine Hundred Ninety-Five Dollars (\$63,995.00); and in the event negotiations fail, authorizing the Interim City Manager and Interim City Attorney to negotiate and execute an agreement with the next lowest, responsive firm until an agreement is executed.

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.


