

RESOLUTION NO. 2016-R-49

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UPS FOUNDATION FOR GRANT FUNDS FROM THE KEEP AMERICA BEAUTIFUL/UPS COMMUNITY TREE AND RECOVER TREE PLANTING GRANT PROGRAM; PROVIDING AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") is desirous of applying for a Keep America Beautiful/UPS Community Tree and Recover Tree Planting grant from the UPS Foundation; and

WHEREAS, the City is requesting a grant in the amount of Five Thousand Dollars (\$5,000.00) with no required match for a total project cost in the amount of Five Thousand Dollars (\$5,000.00); and

WHEREAS, the funds will be used to plant native magnolia trees in medians in Sunkist Grove to beautify corridors in the neighborhood and to plant bald cypress trees in the central area of the City in flood prone swales; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the UPS Foundation.



Section 1. Authorization for Submittal of Application. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submittal of the City's application for a Keep America Beautiful/UPS Community Tree and Recover Tree Planting grant from the UPS Foundation.


