

RESOLUTION NO. 2016-R-64

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER TO FAST-DRY CORPORATION, IN THE AMOUNT NOT TO EXCEED FORTY-EIGHT THOUSAND NINE HUNDRED NINETY-FIVE DOLLARS (\$48,995.00), TO PRESSURE CLEAN, PATCH, RESURFACE AND PAINT TWELVE (12) TENNIS COURTS AT THE SANS SOUCI TENNIS CENTER; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) is in need of pressure cleaning, patching, painting, and resurfacing the twelve (12) asphalt tennis courts at the Sans Souci Tennis Center, including a fiberglass membrane casing of the courts where required (collectively referred hereto as “Services”); and

WHEREAS, City administration obtained competitive quotations from different companies offering the needed Services; and

WHEREAS, in response to the request for quotations, Fast-Dry Corporation (“Contractor”) was competitively selected by City administration for the provision of Services, at a cost not to exceed Forty-Eight Thousand Nine Hundred Ninety-Five Dollars (\$48,995.00); and

WHEREAS, Contractor will complete Services within a period of thirty (30) days from the City’s issuance of a Notice to Proceed, and will include a workmanship guarantee for a period three (3) years following completion of Services; and


WHEREAS, the Mayor and City Council find the provision of Services required for the proper use and enjoyment of the Sans Souci Tennis Center, is in the best interest of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue a purchase order to Fast-Dry Corporation, in the amount not to exceed Forty-Eight Thousand Nine Hundred Ninety-Five Dollars (\$48,995.00), to pressure clean, patch, resurface and paint twelve (12) tennis courts at the Sans Souci Tennis Center.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
