

RE: Program Fee Reduction Policy



RECOMMENDATION

Staff is recommending approval of the resolution creating a policy to offer reduced program registration fees to qualified North Miami households.

BACKGROUND

During the January 10, 2012 Council Meeting, Mayor Pierre made a recommendation that the City offer reduced fee athletic programming for the youth of North Miami. The thought is that parents/guardians are not able to enroll their children in athletic programs because the downturn in the economy has caused individuals to use their limited income to pay for other household needs.

In order to create a system that is equitable to all, the Parks and Recreation Department is recommending use of the most current income limits provided by the Florida Housing Finance Corporation for the State Housing Initiatives Program. For an applicant to qualify for a fee reduction, the household income must be at or below 80% of the Miami-Dade County median income based on the number of persons residing in the household. Some examples of households that would qualify are:

- Households with three people that earned less than \$47,250 for the year
- Households with six people that earned less than \$60,900 for the year

Due to the quick turnaround for this item, the Parks and Recreation Commission have not had an opportunity to review or provide comment on this item.

RESOLUTION NO. _____

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING A PROGRAM FEE REDUCTION POLICY FOR THE PARKS AND RECREATION DEPARTMENT TO REDUCE ATHLETIC PROGRAM FEES FOR QUALIFYING HOUSEHOLDS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) offers youth athletic and aquatic programs (“Programs”) to children residing in the City, upon payment of a program registration fee (“Fee”); and

WHEREAS, each year, a large number of children are unable to enroll and participate in available Programs due to limitations of household income, exacerbated by harsh economic times; and

WHEREAS, during the January 10, 2012, the Honorable Mayor Pierre recommended the adoption of a policy designed to reduce the Fee payable for children that reside in households that fall below the Miami-Dade County median income level; and

WHEREAS, the City’s Parks and Recreation Department (“Parks Department”) has developed a Program Fee Reduction Policy as an equitable means to assist those children currently unable to afford the Fee; and

WHEREAS, in order to increase the number of children from qualified households to participate in Programs, the City Manager respectfully recommends approval of the proposed Program Fee Reduction Policy; and

WHEREAS, the Mayor and City Council find that the proposed Program Fee Reduction Policy is fair, reasonable, and in the best interest of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Adoption of Program Fee Reduction Policy. The Mayor and City Council of the City of North Miami, Florida, hereby adopt a Program Fee Reduction Policy for

the Parks and Recreation Department to reduce athletic program fees for children that reside in qualified households, attached hereto as "Exhibit A".

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.

City of North Miami Program Fee Reduction Policy

It is the City of North Miami's desire to make all youth athletic and aquatic programs available to the residents of North Miami. In order to accommodate the City's youth, the Parks and Recreation Department has developed a program fee reduction policy. The policy was developed to assist those that are currently unable to afford the approved fees for these programs. This policy currently applies to our youth athletic and aquatic programs. The policy does not apply to camps or specialty programs (dance, little league baseball, optimist football, tennis, etc.).

Only City of North Miami residents will be eligible for fee reductions.

Any parent/guardian who requests the program fee reduction application will be provided one without question. The application must be completed by the parent/guardian and submitted to the Parks and Recreation Department's Administrative Office (12300 NE 8 Avenue) a minimum of one week prior to the start of the program.

The application must have a photocopy of support documents which indicate household income, number of people in household, proof of dependency/custody of child and proof of residency.

- Prior year income tax return with the attached W-2 forms.

Your income tax return and appropriate W-2 forms will satisfy the documentation requirements. Without this documentation, a combination of two or more of the following will be required to satisfy the documentation requirements:

- Proof of unemployment benefits, Social Security Income, or other income
- Proof of Medicaid or Food Stamps qualification
- Proof of Guardianship, Birth Certificates

The guidelines for the fee reduction will be based off the most current income limits provided by the Florida Housing Finance Corporation for the State Housing Initiatives Program. In order for an applicant to qualify for a fee reduction, the household income must be at or below 80% of the Miami-Dade County median income based on the number of persons in the household.

If a household is deemed eligible for a fee reduction, they will be entitled to an 80% reduction on the appropriate athletic or aquatic program registration fee. From time-to-time 100% of the registration fee will be waived for specific programs. A participant is eligible for up to one athletic program fee reduction and one aquatic program fee reduction per calendar year. In most cases, the fee reduction will not cover uniform fees and/or any other special fees.

City of North Miami Program Fee Reduction Application

It is the City of North Miami's desire to make all youth athletic and aquatic programs available to the residents of North Miami. In order to accommodate the City's youth, the Parks and Recreation Department has developed a program fee reduction policy. The policy was developed to assist qualified applicants with the approved fees for these programs.

A limited number of scholarships are available for each program and will be awarded on a first-come first-served basis. All scholarships are contingent upon eligibility and available funding. The completed and signed application with the required attachments must be submitted to the Parks and Recreation Department's Administrative Office (12300 NE 8 Avenue) a minimum of one week prior the start of the program. A final decision regarding this application will be provided within two (2) business days from the date the completed application is submitted.

Fee reductions will be based off the most current income limits provided by the Florida Housing Finance Corporation for the State Housing Initiatives Program. Gross annual household income and the number of people living in the household will be used to determine eligibility. Incomplete applications will not be processed or considered.
