A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING A CERTIFICATE OF PARTICIPATION WITH MIAMI-DADE COUNTY FOR AN EDWARD BYRNE JUSTICE ASSISTANCE PROGRAM GRANT (JAG); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Edward Byrne Memorial Justice Assistance Grant (“JAG”) provides funding for the purpose of technical assistance, training, personnel, equipment, supplies, contractual support and information systems for criminal justice; and

WHEREAS, Miami-Dade County is providing to the City of North Miami a portion of federal funds in the amount of Six Thousand Four Hundred Seventy-Eight Dollars (\$6,478.00); and

WHEREAS, funds will be used to purchase two (2) laptop computers, computer accessories, and an oxygen forensic kit to enhance the efficiency of domestic violence investigations; and

WHEREAS, the Mayor and City Council wish to ratify a Certificate of Participation with Miami-Dade County for the purpose of securing grant funds from the county.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:
