**RECOMMENDATION**

It is recommended that the Mayor and City Council approve the attached resolution authorizing the City Manager and City Attorney to submit an application, and negotiate and execute an agreement between the city of North Miami and the State of Florida Department of Transportation.

**BACKGROUND**

The city of North Miami has submitted a concept paper for a project at a total cost of \$120,000 with no required match. Funds will be used towards impaired driving saturation patrols, DUI checkpoints and educational sessions focused on the dangers of impaired driving.

Funding cycle runs from October 1, 2012 through September 30, 2013.

All deliverables are specified in the contract.

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR A GRANT FROM THE ZERO TOLERANCE IMPAIRED DRIVING ENFORCEMENT PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council are desirous of applying for and securing a grant from the Florida Department of Transportation's Zero Tolerance Impaired Driving Enforcement Program; and

**WHEREAS**, the City of North Miami has submitted a concept paper for a project at a total cost of One Hundred Twenty Thousand Dollars (\$120,000.00) in grant funds with no required match; and

**WHEREAS**, funds will be used toward impaired driving saturation patrols, DUI checkpoints, and educational sessions focused on the dangers of impaired driving; and

**WHEREAS**, the Mayor and City Council wish to authorize the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the Florida Department of Transportation for the purpose of securing grant funds.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Submittal of Application.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the submittal of the City of North Miami's application for a grant from the Florida Department of Transportation's Zero Tolerance Impaired Driving Enforcement Program.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami and the Florida Department of Transportation.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
