**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, INITIATING THE PROCESS, CONDUCTING A STUDY AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY FOR THE PROPOSITION OF REDUCING SPEED LIMITS IN RESIDENTIAL DISTRICTS WITHIN THE CITY OF NORTH MIAMI; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, Sections 316.183 and 316.189, Florida Statutes, respectively, govern the establishment of municipal speed zones and limits; and

**WHEREAS**, under 316.189(2)(a), with respect to a residential district, a municipality may set a maximum speed limit of 20 or 25 miles per hour on local streets and highways after an investigation determines that such a limit is reasonable; and

**WHEREAS**, the Mayor and City Council of the City of North Miami wish to initiate the process for reducing residential speed limits in the best interest of the residents of the City; and

**WHEREAS**, the City administration is hereby authorized to conduct a study under state law and do all things necessary for the proposition of reducing residential speed limits; and

**WHEREAS**, the Mayor and City Council believe that it would be in the best interests of the residents of North Miami to pass this Resolution.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.** **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.

**Section 2.** **Authorization to City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to initiate the process, conduct the study and do all things necessary for the proposition of reducing speed limits within the residential districts in the City of North Miami.

**Section 4.** **Effective Date.** This Resolution shall become effective immediately upon adoption.
