**RECOMMENDATION**

Appointments will be made by the Mayor and each Councilperson in order of seniority, and then in alphabetical order. The appointment order will be: Councilman Galvin, Vice Mayor Steril, Councilman Bien-Aime, Councilwoman Keys and Mayor Tondreau.

The Council will consider the boards in alphabetical order, beginning with the Advisory Committee on the Disabled and concluding with the Youth Opportunity Board. The most senior member will make the first appointment to the first board, with subsequent appointments made in order of seniority until all vacancies have been filled on that board. The City Council will then consider the succeeding boards continuing with the second most senior member.

Attached to this report are sixteen (16) schedules, which indicate the various boards that have vacancies or members with expiring terms. Each schedule delineates the statutory reference for the board, the number of members, special qualifications and current membership. An "X" under "Term Expires" indicates that position is up for appointment at tonight's meeting. The appointments should be made in the order represented on each respective schedule.

**BACKGROUND**

The procedure employed by the City Council for appointing the vacancies on the Boards of the City in 2009, will be employed at the June 25, 2013, City Council meeting.
