PUBLIC NOTICE

The City of North Miami is an entitlement community eligible to receive assistance under the U.S. Department of Housing and Urban Development (HUD). The City of North Miami is anticipating an announcement from the United States Department of Housing and Urban Development regarding the Fiscal Year (FY) 2018-2019 Community Development Block Grant (CDBG) and HOME Partnership Investment Program (HOME) allocations. In accordance with the federal regulations, 24 CFR, Part 91, the City of North Miami is preparing a draft Annual Action Plan (AAP) for its 2018-2019 Community Development Programs and intends to submit its AAP to HUD by August 15th, 2018. This document is a requirement for direct assistance under HUD funding programs. The proposed FY 2018-2019 Annual Action Plan is a component of the 2015-2019 Consolidated Plan that identifies resources and strategies to assist in meeting the housing and community development needs and includes plans for monitoring performance. The approved allocation amount for Fiscal Year (FY) 2017-2018 was **\$698,978.00** in CDBG funds and **\$208,444.00** in HOME funds. CDBG and HOME will be used for public facilities and infrastructure improvements, public services, affordable housing related projects, and economic development.

As part of the planning process, the City of North Miami is conducting workshops to solicit public input on programs and activities eligible for CDBG and HOME funding and to prioritize such programs and activities for eligible areas citywide. Residents are invited to attend and participate in these discussions. The locations and dates of the meeting are as follows.
