



**Building and Minimum Housing**

<p><b><u>Double Fees –Work Commenced Without a Permit</u></b></p> <p>When work for which a permit is required is commenced prior to the obtaining of a permit, the permit applicant will be required to pay one hundred dollars (\$100.00) plus a double permit fee. The payment of the required fee shall not relieve them from being subject to any of the penalties therein. The double fee requirements shall be applicable to all divisions of the Department as noted herein.</p>	<p><b>First offense: \$100.00</b></p> <p><b>Plus a double permit fee</b></p>
<p>For second offense of doing work without a permit, the permit applicant shall be required to pay twice the double permit fees plus two hundred dollars (\$200.00).</p>	<p><b>Second offense: \$200.00</b></p> <p><b>Plus twice the double permit fee</b></p>
<p>For each offence thereafter, the permit applicant shall be required to pay twice the double permit fee plus five hundred dollars (\$500.00).</p>	<p><b>Additional offenses: \$500.00</b></p> <p><b>Plus twice the double permit fee</b></p>
<p><b><u>Re-inspection Fees</u></b></p> <p>A permit holder shall be entitled to an initial and follow-up inspection for each mandatory inspection. All work shall be inspected and deficiencies shall be noted by the building inspector. When the work to be inspected is only partially complete, the inspection shall be performed on those portions of the work completed, provided that compliance with Florida Building Code may be determined with respect to those portions. A permit holder shall pay a fee of <b>\$78.78</b> for each additional inspection required to assure compliance with the Florida Building Code beyond the initial and one follow-up inspection. All additional inspection fees shall be paid prior to a final inspection being conducted.</p> <p><b><u>Permit Renewal Fees</u></b></p> <p><b><u>Lost, Revised and Reworked Plans Fee</u></b></p> <p>(a) <b>Lost Plans:</b> When plans for new buildings and additions are lost by the owner or contractor, a recertification fee will be required to review, stamp and approve a new set of plans as a field copy.
