- **Proposal:** Annual Miami-Dade Women’s Leadership Summit

The North Miami Commission for Women proposes hosting an Annual Miami-Dade Commission for Women Summit, uniting women leaders across the county to:

- Strengthen partnerships and share best practices
- Highlight innovative community initiatives
- Identify shared challenges and collaborative solutions
- Empower women to lead and serve more effectively

Purpose:

To create a unified space where city, county, and community leaders collaborate on advancing equity, leadership, and opportunity for women and girls across Miami-Dade County.

Proposed Timeline:

Spring 2026 (March, Women's History Month)

Proposed Partners:

Miami-Dade County Commission for Women, municipal commissions throughout the county, chambers of commerce, educational institutions, nonprofit organizations, and community advocacy groups.

Expected Outcomes:

- Development of a countywide network of women's commissions and leaders.
- Launch of joint initiatives addressing education, economic opportunity, health, and safety for women and girls.
- A published summary report outlining key recommendations and next steps for implementation.

This annual summit will serve as a collaborative platform for leadership, innovation, and impact, ensuring Miami-Dade County remains at the forefront of advancing women's rights and representation.
