

**RESOLUTION NO. 2021-R-15**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING  
AN AMENDMENT TO THE 2020-2021 COMMUNITY  
DEVELOPMENT BLOCK GRANT (“CDBG”) AND HOME  
INVESTMENT PARTNERSHIPS PROGRAM (“HOME”)  
ANNUAL ACTION PLAN TO REFLECT A REDUCTION IN  
FUNDS IN THE AMOUNT OF ONE HUNDRED SEVENTY-  
ONE DOLLARS (\$171.00) FOR A REVISED TOTAL  
AMOUNT OF ONE MILLION SIXTY-SEVEN THOUSAND  
FIVE HUNDRED SEVENTEEN DOLLARS (\$1,067,517.00)  
ALLOCATED TO THE CDBG AND HOME PROGRAMS;  
PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL  
OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) has received Community Development Block Grant (“CDBG”) and HOME Investment Partnerships Program (“HOME”) grant funds from the U.S. Department of Housing and Urban Development (“HUD”), in order to provide a source of funding for various community and economic development programs and projects; and

**WHEREAS**, HUD program regulations require the City to prepare an annual Action Plan in order to receive CDBG and HOME funds; and

**WHEREAS**, on October 13, 2020, the City adopted the fiscal year 2020-2021 Action Plan for the HOME and CDBG grant programs under Resolution 2020-R-116; and

**WHEREAS**, on December 17, 2020, HUD notified the City of an error in HUD’s initial formula allocation for the fiscal year 2020 Community Development Block Grant (CDBG) and the HOME Investment Partnerships Program (HOME) that resulted in a reduction in the City’s total allocation of \$117.00 and \$54.00 respectively for a revised total of \$1,067,517.00; and

**WHEREAS**, the Mayor and City Council find the amendment to the CDBG and HOME Action Plan to reflect the correct amount allocated to the City of North Miami by HUD will facilitate housing rehabilitation for low- and moderate-income City residents and serves the best interest of the City.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Amendment to Fiscal Year 2020-2021 HOME and CDBG Action Plan.**

The Mayor and City Council of the City of North Miami, Florida, hereby approve an amendment to the CDBG and HOME Action Plan to reflect a reduction in the allocation of funds by \$171.00 for a revised total amount of One Million Sixty-Seven Thousand Five Hundred Seventeen Dollars (\$1,067,517.00) for fiscal year 2020-2021 CDBG and HOME programs.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
