

RESOLUTION NO. 2021-R-18

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING AND ADOPTING THE ATTACHED FISCAL YEAR 2021-2022 LOCAL FUNDING AND INITIATIVE REQUEST, WHICH IS TO BE PRESENTED TO THE CITY'S STATE REPRESENTATIVES FOR THEIR CONSIDERATION DURING THE 2021 FLORIDA LEGISLATIVE SESSION; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, as a function of the City of North Miami ("City") state legislative program, the City administration has prepared a local funding and initiative request needed to fund the City's replacement of the South Florida Water Management District C-8 canal pedestrian bridge; and

WHEREAS, the City administration respectfully requests that the Mayor and City Council approve the local funding and initiative request presented hereto for adoption; and

WHEREAS, the Mayor and City Council find that the request is in the best interest of the City and its residents.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

**Section 1. Adoption of Local Funding and Initiative Request.** The Mayor and City Council of the City of North Miami, Florida, hereby approve and adopt the Fiscal Year 2021-2022 Local Funding and Initiative request, attached hereto as "Exhibit A", which is to be presented to the City's State Representatives for their consideration during the 2021 Florida Legislative Session.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
