**FY 2019-2020 CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT
(CAPER)**

October 1, 2019 thru September 30, 2020

In accordance with HUD regulations at 24 CFR 91.520, the Housing and Social Services Department (“HSS”) must submit its performance report to the U.S. Department of Housing and Urban Development (“HUD”) within 90 days after the close of the program year. Due to all the interruptions caused by the COVID-19 pandemic, HUD has provided an extension of the deadline for submission and the City of North Miami (“City”) will submit its FY 2019-2020 Consolidated Annual Performance Evaluation Report (CAPER) to the Miami HUD field Office on or before March 31, 2021. The draft of the CAPER covers the period from October 1, 2019 to September 30, 2020 and contains reporting information on community development activities, including but not limited to the City’s progress in carrying out its Five-Year Consolidated Plan, its Annual Action Plan, other actions to further Fair Housing, and status of funds.

The CAPER requires a public comment period of not less than 15 days; therefore, residents and stakeholders will have the opportunity to provide written input, views, and comments on the draft of the FY 2019-2020 CAPER. A summary of citizen comments (if any) relating to activities reported in the subject CAPER draft will be included in the final document before its submission to HUD.

The draft of the CAPER will be available for public review and comment from March 12, 2021 through March 29, 2021 at the Housing and Social Services Department’s satellite office at 13753 NW 7th Avenue, North Miami, FL 33168; North Miami City Hall at 776 NE 125th Street, North Miami, FL 33161, and the City’s website at www.northmiamifl.gov.
