

RESOLUTION NO. 2021-R-48

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF A REGULAR ELECTION FOR MAYOR OF THE CITY OF NORTH MIAMI, HELD ON MAY 11, 2021; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council of the City of North Miami, pursuant to Resolution 2021-R-09, called for a regular election which was held on May 11, 2021, in accordance with the Charter of the City of North Miami; and

WHEREAS, pursuant to law, the results of that election are to be canvassed and certified by the City Council.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Canvassing Returns.** That the Mayor and City Council of the City of North Miami, Florida, have publicly canvassed the returns of the election of May 11, 2021 and have found that 5,221 total ballots were cast at the election for Mayor.

Section 2. **Election Results.** That the Mayor and City Council of the City of North Miami, Florida, have found that 5,221 valid votes were cast for the office of Mayor as follows:

3,334 votes for PHILIPPE BIEN-AIME

1,887 votes for MICHAEL A. ETIENNE

Section 3. **Canvassing Board Findings.** That the Mayor and City Council of the City of North Miami, Florida, sitting as the Canvassing Board have found that PHILIPPE BIEN-AIME has received the highest number of votes for the office of Mayor, and that PHILIPPE BIEN-AIME is declared re-elected and shall hold office as Mayor until the second Tuesday following the general election in May, 2023.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.

PASSED AND ADOPTED by a 4-0 vote of the Mayor and City Council of the City of North Miami, Florida, this 25th day of May, 2021.
