

**RESOLUTION NO. 2021-R-58**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF A RUN-OFF ELECTION FOR COUNCILPERSON FOR DISTRICT NO. 2 IN THE CITY OF NORTH MIAMI, HELD ON JUNE 01, 2021; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council of the City of North Miami, pursuant to Resolution 2021-R-09, called for a regular election which was held on May 11, 2021, in accordance with the Charter of the City of North Miami; and

**WHEREAS**, the Miami-Dade County Canvassing Board found that KEVIN A. BURNS AND KASSANDRA TIMOTHE received the two (2) highest number of votes, and pursuant to the City Charter and Resolution No. 2021-R-09, a run-off election was held in the City on June 01, 2021, between these two (2) candidates for the office of Councilperson for District No. 2; and

**WHEREAS**, pursuant to law, the results of that election are to be canvassed and certified by the City Council.

**NOW THEREFORE, BE IT RESOLVED BY THE VICE MAYOR AS ACTING MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Canvassing Returns.** That the Mayor and City Council of the City of North Miami, Florida, have publicly canvassed the returns of the run-off election of June 01, 2021 and have found that 1,307 total ballots were cast at the election for Councilperson for District No. 2.

**Section 2. Election Results.** That the Mayor and City Council of the City of North Miami, Florida, have found that 1,306 valid votes were cast for the office of Councilperson for District No. 2 as follows:

576 votes for KEVIN A. BURNS

730 votes for KASSANDRA TIMOTHE

**Section 3. Canvassing Board Findings.** That the Mayor and City Council of the City of North Miami, Florida, hereby acknowledge that the Miami-Dade County Canvassing Board has found that KASSANDRA TIMOTHE has received the highest number of votes for Councilperson District No. 2 and that KASSANDRA TIMOTHE is declared elected and shall hold office as Councilperson for District No. 2 until the second Tuesday following the general election in May 2025.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon adoption.
