

RESOLUTION NO. 2021-R-66

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF INTERSTATE CONSTRUCTION, LLC, AS THE LOWEST-RESPONSIVE, RESPONSIBLE CONTRACTOR TO FURNISH MATERIALS, EQUIPMENT, TOOLS, MACHINERY, SUPERVISION, EXPERTISE, AND SERVICES REQUIRED TO PERFORM BRIDGE REPAIR PROJECTS; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR, IN THE TOTAL AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY-FIVE THOUSAND SIX HUNDRED TWENTY-FIVE DOLLARS (\$155,625.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 41-20-21; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, on April 5, 2021, the City of North Miami ("City") advertised *Invitation for Bid No. 41-20-21 – Bridge Repair Project* ("IFB") requesting bids from qualified, licensed and experienced contractors to provide all the necessary labor and materials for bridge repair projects for two (2) bridges located on the east side of the City, in accordance with the terms conditions and specifications contained in the IFB (collectively referred hereto as "Services"); and

WHEREAS, in response to the IFB, Interstate Construction, LLC, ("Contractor") submitted its bid and was competitively selected by City administration as the lowest-responsive, responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the project consists of expansion joint repairs, concrete spall repairs and corrosion repairs to the structural bridge components for two (2) bridges located along North Bayshore Drive over Little Arch Creek canal: Bridge No. 877301 and Bridge No. 877302; and

WHEREAS, Contractor has manifested the capability and willingness of providing Services to the City in the amount not to exceed a total amount of One Hundred Fifty-Five Thousand Six Hundred Twenty-Five Dollars (\$155,625.00); and

WHEREAS, the Mayor and City Council, find the execution of an agreement with the Contractor, specifically for Services designed to protect the public health, safety, and welfare, is in the City's best interest.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

**Section 1. Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Interstate Construction, LLC, as the lowest-responsive, responsible contractor to furnish materials, equipment, tools, machinery, supervision, expertise, and services required for bridge repair projects.


**Section 2. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with the selected contractor, in a total amount not to exceed One Hundred Fifty-Five Thousand Six Hundred Twenty-Five Dollars (\$155,625.00), in accordance with the terms, conditions and specifications contained in *Invitation for Bid No. 41-20-21*.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
