## RESOLUTION NO. 2021-R-85

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF R & D ELECTRIC, INC., AS THE LOWEST-RESPONSIVE AND RESPONSIBLE BIDDER TO PROVIDE ALL LABOR, EQUIPMENT, MATERIALS, SERVICES AND EXPERTISE REQUIRED FOR THE INSTALLATION OF ONE (1) EMERGENCY GENERATOR **OPERATIONS** AT THE UTILITY CENTER, ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 24-20-21; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH R & D ELECTRIC, INC., FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY-THOUSAND FIVE HUNDRED TWENTY-NINE **DOLLARS (\$125,529.00); PROVIDING FOR AN EFFECTIVE** DATE AND ALL OTHER PURPOSES.

WHEREAS, on April 20, 2021, the City of North Miami ("City") advertised *Invitation* for Bid No. 24-20-21 – One Emergency Generator for the utility Operation Center ("IFB"), for the purpose of obtaining sealed bids from qualified and experienced contractors to provide the City with the labor, equipment, materials, transportation, and related services necessary to purchase, install and connect one (1) emergency generator with weatherproof enclosures, in accordance with the terms, conditions and specifications contained in the IFB ("Services"); and

WHEREAS, on May 27, 2021, City administration opened and reviewed three (3) timely-submitted sealed bids, ranking each response in the order of cost from the lowest to the highest, as follows: 1) R & D Electric, Inc.; 2) Electrical Contracting Service, Inc.; and 3) Zabett Engine Services, Inc.; and

WHEREAS, in accordance with City administration's ranking, the City Manager respectfully requests that the Mayor and City Council approve the selection of R & D Electric, Inc. ("Contractor"), as the lowest, responsive-responsible bidder in the provision of Services, and authorize the City Manager and City Attorney to negotiate and execute an agreement at a cost not to exceed One Hundred Twenty-Five Thousand Five Hundred Twenty-Nine Dollars (\$125,529.00); and

WHEREAS, Services are expected to be completed within one hundred fifty (150) days from the City's issuance of a Notice to Proceed to Contractor; and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interests to approve the selection of Contractor and hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services to accomplish the necessary air conditioning unit replacements.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of R & D Electric, Inc., as the lowest, responsive bidder for the installation of one (1) emergency generator at the utility operations center, in accordance with the terms, conditions and specifications contained in *Invitation for Bid No. 24-20-21 – One Emergency Generator for the utility Operation Center*.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services with R & D Electric, Inc., at a cost not to exceed One Hundred Twenty-Five Thousand Five Hundred Twenty-Nine Dollars (\$125,529.00).

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
