

RESOLUTION NO. 2021-R-109

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE CITY MANAGER TO ISSUE
PURCHASE ORDERS TO LYTX, INC. IN THE INITIAL
AMOUNT OF ONE HUNDRED TWENTY-TWO THOUSAND
THREE HUNDRED ONE DOLLARS AND NINETY-EIGHT
CENTS (\$122,301.98) WITH AN ANNUAL SUBSCRIPTION
AMOUNT NOT-TO-EXCEED SIXTY-SIX THOUSAND
DOLLARS (\$66,000.00), UTILIZING THE COOPERATIVE
PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF
THE CITY CODE, ON A CONTRACT AWARDED
THROUGH THE SOURCEWELL COOPERATIVE
PURCHASING PROGRAM, FOR THE CONTINUED
OPERATION OF THE CITY'S DRIVECAM PROGRAM
FOR TWO HUNDRED (200) VEHICLES FOR A TERM OF
FIVE (5) YEARS; PROVIDING FOR AN EFFECTIVE DATE
AND FOR ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) implemented the DriveCam Program in January of 2017 to prevent risky driving behaviors and improve employee/driver safety through monitoring and coaching in an effort to reduce accidents and injuries; and

WHEREAS, the City is desirous of continuing the operation of the DriveCam program to help protect the City, its employees and residents while also resulting in significant cost savings to the City; and

WHEREAS, due to the success of the program, staff is proposing the expansion of the program to add an additional forty-three (43) vehicles for a total of two-hundred (200) vehicles as well as the upgrade of the current equipment to newer camera models with increased functionality; and

WHEREAS, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

WHEREAS, Sourcewell is a national purchasing cooperative that has awarded LYTX Sourcewell Contract No. 020221 in response to RFP No. 020221 - Fleet Management Technologies with Related Software Solutions; and

WHEREAS, in accordance with Section 7-169 of the City Code, the City Administration respectfully requests that the Mayor and City Council authorize the City Manager to issue purchase orders to LYTX, Inc. in an initial amount not to exceed One Hundred Twenty-Two Thousand Three Hundred One Dollars and Ninety-Eight Cents (\$122,301.98) with an annual subscription amount not to exceed Sixty-Six Thousand Dollars (\$66,000.00); and

WHEREAS, the Mayor and City Council find the continuation of the DriveCam Program, by authorizing the City Manager to issue Purchase Orders to LYTX, Inc., will greatly contribute to the important mission of rendering public services in a manner that will help preserve the public health, safety and welfare.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue Purchase Orders to LYTX, Inc., in an amount not to exceed One Hundred Twenty-Two Thousand Three Hundred One Dollars and Ninety-Eight Cents (\$122,301.98) with an annual subscription amount not to exceed Sixty-Six Thousand Dollars (\$66,000.00) utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, on a contract awarded through the Sourcewell Cooperative Purchasing Program for a term of five (5) years.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
