

**RESOLUTION NO. 2021-R-105**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER TO ISSUE  
PURCHASE ORDERS TO BRASCO INTERNATIONAL,  
INC., AS THE SOLE SOURCE MANUFACTURER AND  
DISTRIBUTOR OF BAYLINE SERIES SHELTERS, IN  
ACCORDANCE WITH SECTION 7-143 OF THE CITY  
CODE OF ORDINANCES, AT A COST NOT TO EXCEED  
THIRTY-ONE THOUSAND THREE HUNDRED FIFTY  
DOLLARS (\$31,350.00), FOR THE REPLACEMENT OF  
THREE (3) BUS SHELTERS; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on February 28, 2006, the City of North Miami (“City”) entered into an Agreement with CEMUSA Miami, LTD to provide the services necessary to maintain the City’s bus shelter program; and

**WHEREAS**, the contract was terminated in 2010 and subsequently, the company went out of business leaving the City with thirty (30) Bayline Series Shelters and nine (9) CEMUSA Model Shelters; and

**WHEREAS**, three (3) of the CEMUSA model shelters needed major structural improvements and City staff recommends the replacement of these bus shelters with the Bayline Series Shelters to have a Citywide standardized model with the ultimate goal of replacing all of the existing CEMUSA Models with the Bayline Series throughout the City; and

**WHEREAS**, Section 7-143, City Code of Ordinances, allows for the purchase of goods and services without the necessity of competitive bids or proposals when only one reasonable source of supply is available; and

**WHEREAS**; Brasco International is the sole manufacturer and distributor of the Bayline Series Shelters; and


**WHEREAS**, City administration respectfully requests that the Mayor and City Council authorize the sole source procurement of Bayline Series Shelters necessary for the standardization of the City’s business shelters, at a cost not to exceed Thirty-One Thousand Three Hundred Fifty Dollars (\$31,350.00).

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Bracco International, Inc., as the sole source manufacturer representative of Bayline Series Shelters, in accordance with Section 7-143 of the City Code of Ordinances, at a cost not exceed Thirty-One Thousand Three Hundred Fifty Dollars (\$31,350.00).

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
