

**RESOLUTION NO. 2021-R-102**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING LOUIS PRESUME TO THE NORTH MIAMI PARKS AND RECREATION COMMISSION, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 5, SECTION 2-187, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the purpose of the North Miami Parks and Recreation Commission is to: prepare and recommend a comprehensive master plan for the park and recreation services and needs, review and evaluate the parks and recreation department annual budget and capital improvement proposals, serve in a liaison capacity between the public and the city council, and serve as a public relations interface to the general public; and

**WHEREAS**, Chapter 2, Article III, Division 5, Section 2-187, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint two (2) members to the Parks and Recreation Commission; and

**WHEREAS**, appointees shall reside in the City of North Miami and shall not be an employee of the city, in accordance with Section 2-186 of the City Code; and

**WHEREAS**, Councilwoman Mary Estimé-Irvin desires to re-appoint Louis Presume to the North Miami Parks and Recreation Commission as one of her two appointees.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.

**Section 2.**      **Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby re-appoints Louis Presume to the North Miami Parks and Recreation Commission.

**Section 3.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
