

**RESOLUTION NO. 2021-R-99**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING ANGELO-NATHAN FLEURIME TO THE NORTH MIAMI YOUTH COUNCIL, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 11, SECTION 2-257, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the purpose of the North Miami Youth Council is to provide the youth of North Miami with a vehicle to learn about government, participate in the process of City of North Miami government, represent and articulate the needs of youth in the city, and advise the mayor and city council on matters affecting the youth and teen population, especially city programs relating to youth and teens.; and

**WHEREAS**, Chapter 2, Article III, Division 11, Section 2-257, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint two (2) members to the Youth Council; and

**WHEREAS**, appointees shall reside in the City of North Miami, shall be students in the 10th, 11th, or 12th grade and shall demonstrate a sincere interest and the motivation to work for the community and have a background in community-based activities, in accordance with Section 2-257 of the City Code; and

**WHEREAS**, Councilwoman Mary Estimé-Irvin desires to appoint Angelo-Nathan Fleurime to the North Miami Youth Council as one of her two appointees.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.


**Section 2.      Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby appoints Angelo-Nathan Fleurime to the North Miami Youth Council.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
