

RESOLUTION NO. 2021-R-131

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE PUBLIC RIGHTS PROJECT, A
PROJECT OF THE TIDES CENTER, COMMUNITY
JUSTICE PROJECT, AND SOUTHERN POVERTY LAW
CENTER TO FILE A LAWSUIT ON BEHALF OF THE CITY
OF NORTH MIAMI, FLORIDA, THAT FACIALLY
CHALLENGES HB 1 (2021); PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) exercises control over its annual budget as a means to respond to the diverse needs, interests, and values of the community it represents; and

WHEREAS, the City recognizes that its municipal budgetary allocation is a direct reflection of its values and commitment to the public; and

WHEREAS, the City uses its budget, of approximately \$161 million, to support services, infrastructure, and programmatic needs of its diverse population of over 65,000 residents; and

WHEREAS, on April 20, 2021, Florida House Bill (“HB 1”) took effect in the State of Florida; and

WHEREAS, Section 1 of HB 1 creates a State executive review process that is triggered when a City Councilperson or the State Attorney in the applicable Judicial Circuit objects to a funding reduction to the operating budget of the City’s law enforcement agency; and

WHEREAS, HB 1 delegates this process to the Administration Commission comprised of the Governor and Cabinet, which has the power to amend or modify the budget as to each separate line item within the operating budget of the City’s law enforcement agency with no limiting principles on the Administration Commission’s discretion; and

WHEREAS, the Administration Commission’s amendment of the municipality’s budget is final, and HB 1 does not set forth any mechanism for judicial review of the Administration Commission’s budget amendments; and

WHEREAS, HB 1 poses serious constitutional and civil liberties issues, including potential violations of the Equal Protection Clause, the Due Process Clause, and the First Amendment of the U.S. Constitution; and and

WHEREAS, Public Rights Project, Community Justice Project and Southern Poverty Law Center have expressed their interest in filing litigation challenging the constitutionality of HB 1 on behalf of the City of North Miami; and


WHEREAS, the Mayor and City Council have weighed the considerations, including the protection of the City of North Miami's budgeting authority and municipal autonomy, and desires to move forward as a participant in the litigation.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authorization to File Litigation. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Public Rights Project, Community Justice Project, and the Southern Poverty Law Center to file a lawsuit bringing a facial challenge to HB 1 on behalf of the City as a Plaintiff, seeking declaratory, injunctive, and other appropriate relief.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption
